Fern Landry wins prestigious APSA Guard of the Year Award

OTTAWA – Commissionaire Fern Landry has been announced as the recipient of the APSA Guard of the Year Award. This prestigious award recognizes outstanding performance in the security profession and is given out annually by the Association of Professional Security Agencies (APSA), whose 18 member companies represent over 30,000 private security guards across Ontario.
